

# In the Supreme Court of the State of Idaho

**IN RE: FORMATION AND MEMBERSHIP OF  
THE ADVANCING JUSTICE COMMITTEE**

**AMENDED ORDER**

The Idaho Supreme Court, having received a recommendation from Senior Judge Barry Wood, amends the July 5<sup>th</sup>, 2012 Court Order appointing the Advancing Justice Committee, as follows:

The Advancing Justice Committee is appointed to further the Court's Mission to provide access to justice by ensuring fair processes and the timely, impartial resolution of cases, consistent with Article I, Section 18, of Idaho's Constitution.

The Advancing Justice Committee is guided by the following principles:<sup>1</sup>

1. Every case receives individual attention.
2. Individual attention is proportional to need.
3. Decisions demonstrate procedural justice.
4. Judges control the legal process.
5. Unnecessary delay in case processing is prevented when possible.

The Committee shall perform the following tasks:

- Identify and promote court practices that enhance procedural fairness for litigants.
- Facilitate development and implementation of statewide and district caseload management plans pertaining to major case types.
- Identify and promote effective caseload management practices that reduce unnecessary delay and promote timely case processing.
- Identify and recommend statutory and rule changes as appropriate.
- Develop educational programs relating to caseload management for judges and other court staff.

- Identify and address technical assistance needs relating to caseload management and procedural fairness on both a statewide and district court level.
- Refine case management reports and develop other tools to support data-informed caseload management practices.

It is further ordered that the Advancing Justice Committee shall meet regularly and shall report periodically to the Court and to the Administrative Conference on actions taken as well as recommendations for legislative and rule changes and other significant policy improvements. As case management data become available through the Odyssey system, the Court, Administrative Conference, and the Advancing Justice Committee shall be provided with regular reports to inform statewide policies and practices in the area of caseload management.

It is further ordered that committee members initially appointed in July of 2012 are reappointed for a one-year or two-year term, as indicated below. Any new appointments to the Committee will be for a two-year term. The following individuals are re-appointed:


