PREFILING ORDER

DANA ROSE,

A vexatious litigant.

On April 29, 2015, pursuant to Idaho Administrative Rule 59(e), this court issued a Proposed Prefiling Order which set forth a proposed order declaring DANA ROSE a vexatious litigant based upon Findings of Fact and Conclusions of Law, issued the same date. DANA ROSE was given fourteen (14) days to file a written response. On May 11, 2015, DANA ROSE filed a response.¹ Having read this response, the court determines

in its discretion that a hearing is not merited and that there is a basis for issuing a prefiling order.


THEREFORE, this court orders as follows:

- 1) DANA ROSE is declared to be a vexatious litigant pursuant to Idaho Administrative Rule 59. This declaration is based upon the findings previously made by this court on April 29, 2015.
- 2) Based thereon, DANA ROSE is hereby PROHIBITTED from filing any new litigation in the courts of this state *pro se* without first obtaining leave of a judge of the court where the litigation is proposed to be filed.
- 3) Disobedience of this order is punishable as a contempt of court and any action filed by DANA ROSE without prior leave of court may be dismissed by the court.

PURSUANT TO Idaho Administrative Rule 59(f) this order may be appealed to the Idaho Supreme Court as a matter of right.
