

## Roster of Conditionally Approved Court Interpreters

*As of May 24, 2016*

This roster includes the names of persons who have passed a written screening exam, attended a two-day orientation workshop, and sat for the oral certification exam and received an overall score of 55 percent or higher without reaching the Certified or Master level, with no single score falling below a 50 percent, including on the separate sight translation scores. An individual may fall under this level of qualification for a period of two years. The Idaho Administrative Office of the Courts does not have available any information as to the ability of these interpreters to serve in the courts.

As a member of the Consortium for State Court Interpreter Certification, the Idaho Administrative Office of the Courts has access to certification exams for the following languages: Arabic, Bosnian Serbian, Croatian, Cantonese, French, Haitian-Creole, Hmong, Ilocano, Korean, Laotian, Khmer, Mandarin, Marshallese, Polish, Portuguese, Russian, Somali, Spanish, Tagalog, Turkish and Vietnamese.
