GENERAL INFORMATION

1. Registration: Qualifications of Private Civil Litigation Evaluators

To be placed on the Supreme Court's list of private civil litigation evaluators, the applicant must be a member of the Idaho State Bar in good standing who has been a member of the Idaho State Bar for a period of not less than seven (7) years, or be a retired or senior justice or judge. In addition, the applicant must be familiar with the Small Lawsuit Resolution Act (Section 7-1501, *et seq.*, Idaho Code) and the rules of the Idaho Supreme Court governing the resolution of civil disputes in the district courts of the State of Idaho.

2. Supporting Documentation

An applicant must submit the following to be placed on the list of evaluators maintained by the Supreme Court:

- A. The attached application; and
- B. An affidavit of compliance executed by the applicant attesting that the applicant has fulfilled the requirements for registration.
