2020

ADMINISTRATIVE ORDER  
2020-18

WHEREAS on July 24, 2020, the Idaho Supreme Court issued its Order entitled "In Re: Jury Trials," the provisions of which govern the conduct of jury trials in Idaho ("Jury Trial Order"); and,

WHEREAS on September 10, 2020 the Idaho Supreme Court issued a further Order regarding Jury Trials entitled "Re: Commencement of Jury Trials" ("Jury Trial Commencement Order") that requires the Administrative District Judge to review the Cases by County page of the Idaho Department of Health and Welfare's COVID-19 Data Dashboard (Dashboard) each week to determine if criminal jury trials may proceed for a particular county for a given week; and

WHEREAS the Administrative District Judge has determined upon review of the DPH Idaho COVID-19 Dashboard numbers as of 11/06/2020; and

WHEREAS Governor Little has issued a Statewide Public Health Order (10/26/2020) moving Idaho back to Stage 3; and

WHEREAS local hospitals are not accepting new patients due to capacity issues and shortage of healthcare workers; and


WHEREAS there has been an inability to secure sufficient numbers of potential jurors for trials; and

WHEREAS cancelling trials on Friday for the following Monday and preparing for vacated trials has caused undue stress and expense for clerks, judges lawyers, witnesses and Jury Commissioners;

**NOW THEREFORE, IT IS HEREBY ORDERED** that pursuant to Section 4 of the Jury Trial Commencement Order the following Counties of the Second Judicial District SHALL NOT conduct jury trials for the weeks of November 9-13, November 16-20 and November 23-27, 2020 and any jury trial set to proceed during that time frame in those counties shall be vacated and reset:

**Clearwater County, Idaho**  
**Idaho County, Idaho**  
**Latah County, Idaho**  
**Lewis County, Idaho**  
**Nez Perce County, Idaho**
