AMENDED ORDER

The Court, having received a recommendation from Honorable Mark Ingram, Chair of the Juvenile Justice Advisory Committee, and in coordination and consultation with Jason Dye, Court Programs and Services Administrator – Juvenile Justice;

NOW, THEREFORE, IT IS HEREBY ORDERED that a multidisciplinary Juvenile Justice Advisory Committee, in furtherance of Idaho's balanced approach to the juvenile justice system, accomplish the following:

1. Build collaboration with juvenile justice stakeholders;
2. Research and study the operation of Idaho's juvenile justice system to improve practices and outcomes for juveniles and their families;
3. Promote the implementation of evidence-based practices to accomplish the goals of the Juvenile Corrections Act (JCA);
4. Recommend changes to rules or statutes to improve the operation of the juvenile justice system;
5. Assist with implementation of juvenile case flow management plans;
6. Collaborate with the Supreme Court Treatment Court Committee to promote effective practices in Idaho's juvenile drug and mental health courts;
7. Collaborate with the Supreme Court Child Protection Committee to promote policies and practices aimed at improving outcomes for dually adjudicated (crossover) youth;
8. Develop, recommend, and maintain statewide juvenile justice forms; and
9. Promote the implementation of data sharing among system.

IT IS FURTHER ORDERED that the following changes be made to the Juvenile Justice Advisory Committee:




