

# In the Supreme Court of the State of Idaho

**IN RE: EVIDENCE RULES  
ADVISORY COMMITTEE**

**ORDER REACTIVATING THE  
EVIDENCE RULES ADVISORY  
COMMITTEE**

The Idaho Supreme Court has determined that the Idaho Rules of Evidence require updates; that the Evidence Rules Advisory Committee has not met for many years; and that new appointments must be made to reactivate the Committee so it can review proposed revisions to the Idaho Rules of Evidence.

IT IS ORDERED that the Evidence Rules Advisory Committee shall be reconstituted, and that the charge of the Committee shall be as follows:

1. The Committee shall make recommendations to the Court concerning revisions and amendments to the Idaho Rules of Evidence consistent with the purpose of those rules to administer every proceeding fairly, eliminate unjustifiable expense and delay, and promote the development of evidence law, to the end of ascertaining the truth and securing a just determination.
2. At the request of the Court the Committee shall make recommendations to the Court on requested changes to the Idaho Rules of Evidence received from attorneys, court personnel, judges, and the general public.

IT IS FURTHER ORDERED that the following persons are appointed as members of the Committee, to serve for the term indicated or until their successors are selected and appointed by further order of the Court:

Term to expire upon further order of the Court

Term to expire upon further order of the Court

Idaho State Appellate Public Defender's Office  
Three-year term expiring August 31, 2028
5. Kacey Jones  
Office of the Attorney General  
Two-year term expiring August 31, 2027
6. Tara Malek  
Smith & Malek, PLLC  
Two-year term expiring August 31, 2027
7. Jeffrey Brunson  
Beard St. Clair Gaffney, PA  
Three-year term expiring August 31, 2028


