The Court, having determined that input from elected clerks, county IT professionals, judges, and court administrators is vital to informing the Court's decisions regarding technology projects that impact case management and county operations; and upon recommendation of the leadership of the Idaho Association of County Recorders and Clerks and Administrative Director of Courts as to committee membership, the Technology Committee is reformed. The committee shall make recommendations to this Court in order to better inform decisions regarding technology projects that impact case management and county operations. Specifically, the Technology Committee shall make recommendations to this Court regarding:

- 1) The direction of the relevant Idaho courts' information technology (IT) systems;
- 2) The development and maintenance of an Idaho courts' IT strategic plan;
- 3) The development and maintenance of Idaho court's IT policies, including applicability of national information technology standards; Idaho court's IT enterprise architecture; privacy and access; security; and data quality; and
- 4) The operation of Idaho courts' IT program, such as sequencing and funding of IT projects, selection of IT products and applications for purchase or development, priorities for receiving and implementing new or updated IT applications or equipment, IT equipment upgrades and upgrade schedules, and IT education and training.

The Technology Committee shall meet regularly and shall report periodically to the Court and to the Administrative Conference on all such recommendations, including any recommendations for legislative and rule changes, budget enhancements, or other significant policy improvements.
