ORDER

Pursuant to Idaho Code § 32-706(5) encouraging the Idaho Supreme Court to adopt and review child support awards, the Supreme Court hereby appoints a Child Support Guidelines Committee (Committee) to be chaired by the Honorable R. Todd Garbett.

The legislature hereby authorizes and encourages the Supreme Court of the state of Idaho to adopt and to periodically review for modification guidelines that utilize and implement the factors set forth in subsections (1) - (4) and (6) of section 32-7605, Idaho Code, to create a uniform procedure for reaching fair and adequate child support award.


