ORDER

The Idaho Criminal Rules are intended to provide for the just determination of every criminal proceeding in a manner that secures simplicity in procedure, fairness in administration, and elimination of unjustifiable expense and delay. To further this intent, the Idaho Supreme Court formed the Criminal Rules Advisory Committee. The Committee is charged with regularly reviewing the Idaho Criminal Rules to ensure they are serving their intended purpose and with making recommendations regarding the adoption of new rules and the amendment or repeal of existing rules. The Committee is also charged with meeting regularly and reporting periodically to the Administrative Conference and the Supreme Court with the results of its work and any recommendations.

This Court has received a request that the composition of the Criminal Rules Advisory Committee be updated to reflect every judicial district and to attempt to equalize membership from the prosecution and criminal defense bar rosters.




