The Court having established a statewide Domestic Assault and Battery Evaluator Advisory Board (Borad) to establish a uniform system for the qualification and approval of persons, agencies, or organizations to perform the evaluations required in Idaho Code §§ 18-918 and 18-923, and the Court having chosen the members of said Board;

Pursuant to Idaho Court Administrative Rule 75, the Domestic Assault and Battery Evaluator Advisory Board shall consist of eight (8) members with experience and training in domestic violence. Membership shall consist of at least one member from a district judge or magistrate judge and a combination of members from the following: a social worker; a counselor; a psychologist; a judge presiding over a domestic violence court; a domestic court coordinator; a domestic violence offender intervention program provider; a current or past domestic assault and battery evaluator; or a health care provider.

The charge to the Board is as follows:

- A. Recommend qualifications and continuing education of evaluators;
- B. Review and recommend for approval or rejection applications of persons to be evaluators;
- C. Recommend the required content and scope of reports of evaluators under Rule 33.3, Idaho Criminal Rules.

The Honorable Carol "Tippi" Jarman is appointed to the Board and will serve as Chair of said Board until further order of the Court.




