WHEREAS the Education Committee is charged with providing leadership and guidance for the professional development of all judges and court personnel, including:

- Plan and recommend a comprehensive education program for judges from the time of appointment through senior judge service, education for court personnel, and multidisciplinary institutes.
- Develop education policy and other program recommendations;
- Act as an advisory committee on matters relating to judicial education and the education of court personnel;
- Develop agendas and curriculum for education programs;
- Recommend and develop individuals to serve as faculty for education programs;
- Develop distance learning training and recommend materials, manuals, bench books, and other education resources;
- Develop and recommend education technology resources;
- Develop and recommend education resources for training on business processes;
- Utilize effective adult learning techniques for education programs;
- Develop and recommend alternative funding sources for education programs; and
- Provide oversight of judicial performance evaluations.
