In accordance with Idaho Code § 31-3201G, the Court administers the Guardianship and Conservatorship Project "to improve reporting and monitoring systems and processes for the protection of persons and their assets where a guardian or conservator has been appointed."

A strategic goal and major objective of the Idaho Supreme Court is to "protect and empower vulnerable individuals under guardianship or conservatorship through education, monitoring, enforcement, and community support." Therefore, the Supreme Court appointed a Guardianship and Conservatorship Committee (Committee).

The mission statement of the Committee is to "Protect and empower vulnerable individuals under guardianship or conservatorship through education, monitoring, enforcement, and community support. To further the intent of the legislature by recognizing that every individual has unique needs and differing abilities and the system should permit every individual to participate as fully as possible in decisions which affect them, including the use of alternatives to full guardianship or conservatorship."

The Committee is charged as follows:

- To make recommendations to the Court for improving reporting and monitoring systems and processes for the protection of persons and their assets where a guardian or conservator has been appointed in order to ensure safety, health, and well-being of the person under guardianship or conservatorship;
- 2. To make recommendations to the Court for developing and implementing innovative case management practices related to guardianship and conservatorship cases that promote efficient use of court services;
- 3. To make recommendations to the Court for developing and recommending best practices for judges and attorneys to consider alternatives to guardianship and, if guardianship is necessary, encourage guardianship under the least restrictive conditions consistent with the need for protection;
- 4. To make recommendations to the Court for identifying and addressing gaps and improvements to the court system to protect vulnerable individuals;
- 5. To make recommendations to the Court for considering program development, resource development, technical assistance and training opportunities for the development and sharing of best practices; and
- 6. To provide bench cards or guides, develop forms, and establish or update protocols related to all aspects of guardianship and conservatorship proceedings.
