The Court having determined the need to appoint a statewide committee to examine ways of reducing delays for children in foster care, and the Court having chosen the members of the committee, charges the Committee as follows;

A. Identify:

- 1. Factors (practices, procedures, guidelines, statutes, rules) which contribute to delays in reunification:
- 2. Factors (practices, procedures, guidelines, statutes, rules) which contribute to delays in termination of parental rights;
- 3. Factors (practices, procedures, guidelines, statutes, rules) which contribute to delays in permanent placements;
- 4. Terms in the Adoption and Safe Families Act of 1997 which need clarification;
- 5. Successful approaches to child protection cases used in other states.
- B. Provide predictability, security and certainty as soon as possible, make recommendations for reducing delays for children in foster care, including reducing delays in reunification, in terminations, and in permanent placements.
- C. Make recommendations for shared accountability and unified standards of practice within and between the key players including the Court, Tribal Court, Department of Health and Welfare, Prosecutor, Public Defender, Department of Juvenile Corrections, and CASA.
- D. Make recommendations for better coordination between different courts/judges/cases involving the same family, including protection order, juvenile, family, and child protection law across all Idaho counties.
- E. Make recommendations for a unified statewide judicial approach to child protection cases.
- F. Make recommendations for increasing voluntary terminations, including whether and how to accommodate the parents willing to terminate if allowed to maintain some contact in cases where such contact is not detrimental to the child.
- G. Make recommendations for minimizing trauma to children after removal.
- H. Make recommendations regarding the role of long term guardianship/foster care.

The Hon. Andrew Ellis shall serve as Chair of the Committee until further order of the Court.
