- A. Recommend qualifications and continuing education of evaluators;
- B. Review and recommend for approval or rejection applications of persons to be evaluators;
- C. Recommend the required content and scope of reports of evaluators under Rule 33.3, Idaho Criminal Rules.

The Hon. Michelle Mallard serves as Chair of said Board until further order of the Court.
