The justice system can enhance therapeutic outcomes by holding offenders accountable and enhancing victim safety. Offender Accountability and Coordinated Community Response are two commonly used terms when talking about enhanced responses to domestic violence. But what does accountability mean? What is a coordinated community response? This session will explore these terms and discuss how to use a local network of partners to create a "wall of accountability and support" in domestic violence cases. Participants will be able to identify how the system enhances or impedes victim safety & offender accountability and discuss ways of incorporating community partners in the management of offenders and the autonomy of victims.

Treatment Options for Women Who Use Force

Jeffrie Cape, LMSW; Alternatives to Domestic Aggression Program, Ann Arbor, Michigan

Effectively addressing women's use of force in intimate heterosexual relationships is a controversial national issue that affects social service providers at the local, county, and state-wide levels. Women referred to offender intervention programs receive inappropriate "batterers treatment" rather than contextualized support and intervention. Through lack of attention to context, interventions fail to meet the needs of women who have used force and may also fail to meet the goals of the referring agency – to prevent future incidents. This session will explore the issue of women's use of force and how societal assumptions and research have inadvertently created a false understanding of this issue. Participants will have an opportunity to explore key fundamental components to consider in creating or referring women defendants to domestic violence intervention programs.

Room: LIBERTY Strategies for Safety

Jennifer Landhuis, Idaho Coalition Against Sexual and Domestic Violence

This session will provide participants with an understanding of the various strategies that may be used when discussing safety with individuals impacted by violence- both during and after leaving an abusive relationship. Working with victims of domestic violence calls for an approach that goes beyond service-defined. Victim-defined advocacy recognizes that victims should define the advocacy and that service providers must acknowledge that victims are the ultimate decision maker in this partnership. Services for individuals impacted by domestic violence often focus on the strategies for leaving a relationship and fail to recognize that there are numerous factors involved in a victim's decision making and those factors may (and often do) keep a victim in the relationship.

Room: DELAMAR Critical Issues for Working with Immigrant and Limited English Proficient Survivors Rosie Hidalgo, Casa de Esperanza

Immigrant and Limited English Proficient (LEP) survivors often face additional barriers in accessing services and safety. This workshop will focus on enhancing access to services for LEP individuals, improved safety planning for immigrant survivors, and special immigration remedies (such as the VAWA self-petition, U visa and T visa) and ICE prosecutorial discretion to help immigrant victims come out of the shadows and limit the use of immigration status as a tool of abuse or exploitation.

Sexual Assault, Sex Trafficking, and Prostitution

This session will examine the overlap of domestic violence, sexual assault, and trafficking. Participants will learn about sexual assault and the intersection of sexual assault and domestic violence. This session will also cover what is trafficking? - Using your DV lens! We will discuss power and control, types of abuse, pimps as intimate partners and domestic violence as a push factor into prostitution/trafficking.

Ongoing collaboration requires an intensive effort and active participation from all stakeholders to ensure an effective community response to domestic violence. Interagency collaboration is crucial to ensuring communication, consistency, and continuing education about the court and domestic violence. Cross system or multi-disciplinary collaboration can be very rewarding and also difficult because of differing interests and goals, which may be perceived as duplication to already existing services and service providers. This panel from Ann Arbor, Michigan will explore how key stakeholders can assist in identifying existing and new resources and can help bring other key stakeholders to the table. They will also discuss how the domestic violence court judge provides leadership to the interagency collaboration and provide an open discussion on multi-disciplinary collaboration.

8:30-10:00am How Language Helps Shape our Response to Violence Against Women

"Language can never be neutral; it creates versions of reality." Yet when we discuss violence against women, we describe the violence in passive terms, which allows the perpetrators of this violence to remain invisible and unaccountable. We also use language that objectifies or blames victims. This interactive session will explore the language of violence against women: how we talk about and write about these crimes. Participants will learn to recognize the objectifying or blaming language we often use to describe victims. They will explore how to describe violence against women in a way that more accurately depicts the crimes. Participants will also discuss specific and concrete steps they can take to change the language they use to talk about and write about violence against women.

1:45-3:15pm Sentencing in Domestic Violence Cases

A domestic violence court should develop sentencing models that promote accountability and consistency, while also taking into account the context in which the crime occurs. This session will discuss the sentencing objectives in domestic violence cases, what information is needed to meet these objectives, signs to look for when assessing danger, and assessing the future and key elements in delivering the sentence. The presenters will also address the need for court-ordered mandates, such as probation supervision and domestic violence offender intervention/treatment and the importance of ensuring offenders comply.
