This roster includes the names of persons who have passed a written screening exam, attended a two-day orientation workshop, and sat for the oral certification exam and received an overall score of 55 percent or higher without reaching the Certified or Master level, with no single score falling below a 50 percent, including on the separate sight translation scores. An individual may fall under this level of qualification for a period of two years.

Placement on this roster is based on the individual's scores and his or her compliance with administrative requirements set by the Administrative Office of the Court. Certification exams are available for the following languages: Arabic, Bosnian Serbian Croatian, Cantonese, French, Hatian-Creole, Hmong, Ilocano, Khmer, Korean, Laotian, Mandarin, Marshallese, Polish, Portuguese, Russian, Somali, Spanish, Tagalog, Turkish and Vietnamese.
