THE HONORABLE ROBERT E. WAKEFIELD 1936 - 2022

Judge Robert E. Wakefield, Colonel K.R. Liston-Wakefield, USMC, "Bob" lived a life of duty, of service, of adventure, and of love. Born November 24, 1936, he died peacefully with his children at his side after a short battle with cancer. In his 84 years, he achieved more than most could achieve in several lifetimes.

Bob graduated from UC Berkeley in 1959 with military distinction, then graduated from the Marine Corps Command and Staff College, and then graduated from the Naval War College with Highest Distinction. Bob's lengthy list of commands and tours as a Marine officer demonstrates his skills, his commitment, and his courage.

Over time, Col. Wakefield was a Commanding Officer of two Companies, two Battalions, and a Regiment. He was Chief of Staff at Brigade and Fleet Marine Force Headquarters. He commanded two Reconnaissance units and, as a parachutist and scuba diver, pioneered the use of submarines for amphibious reconnaissance. He saw combat in Vietnam and was awarded the Purple Heart during the Tet Offensive and the battle of Hue City. He developed combined arms tactics that prepared the Regiment for Operation Desert Storm. While these accomplishments are impressive, along with many others, Col. Wakefield cherished most the Marines that he led and fought alongside. He was a proud Marine.

Bob was also a scholar of history, literature, music, and lengthy jokes. He maintained a curious mind and sense of humor throughout his life.

Bob "retired" in June 1989 as Chief of the General Staff, Fleet Marine Force Pacific. Of course, he couldn't stop there. Instead, he enrolled at the University of Idaho College of Law and graduated Cum Laude in 1992. His intellect and discipline served him well in law school, and those qualities also served the people he then represented. He founded a law firm in Moscow, Wakefield and Dwelle, and became the supervising attorney in the

Tribal Law Clinic at the law school, representing tribal members in both Nez Perce and Coeur d'Alene Tribal Courts.

Bob's generosity had no bounds. He served as a judge at the College of Law moot court competitions, he presented to law students in a variety of classes, and he mentored many transitioning into the real world of practicing law. As a lawyer, Bob handled a variety of cases, both criminal and civil, including family and probate law. For 26 years, Wakefield and Dwelle served as general counsel to Gritman Medical Center. Bob took on many cases pro bono without hesitation and was active in the district and state bar associations and the Ray McNichols American Inn of Court. He was a respected advocate for his clients, for the law, and for justice.

As if all of this wasn't enough, Judge Wakefield finished his distinguished legal career by serving five years as a Tribal Judge as Chief Judge of the Coeur d'Alene Tribal Court and the Coeur d'Alene Tribal Court of Appeals, again, with distinction.


In addition to his legal advocacy, Bob was tireless in advocating for and supporting veterans. He also supported the Boy Scouts of America, having been an Eagle Scout, and volunteered on the Moscow Volunteer Fire Department where he enjoyed the title of "Firefighter Bob."

Bob may have worn many different hats, but he was always a Marine. And that required physical fitness and adventure. Bob was a runner, a cycler, a fly fisher, a scuba diver, a pilot, a pheasant hunter, a sailor, a rock climber, a mountaineer, and a world traveler. In 2007, Bob served in Kunduz, Afghanistan, for the State Department's Justice Support Program.

Bob will be missed by many: his family, his daughter and son and their spouses, his four grandchildren, his three great-grandchildren, his colleagues, his friends, his Marines.

He has been in service to all of us throughout his life. May he rest in peace, knowing he has left an inspiring legacy of duty, discipline, and generosity.

## THE HONORABLE WILLIAM CARY HAMLETT 1942 – 2022

William Cary (Bill) Hamlett was born in Paris, Texas in 1942. He passed away following a long and fruitful career on February 3, 2022.

Bill's parents were William, a physician, and Mary a public health nurse. Bill's father served in the Navy and went missing in action during his military service in Korea when Bill was 7. After her husband's death, Mary took a job in Ely, Nevada, moving there with Bill (who was known in Ely as "Tex") where he was raised.

Bill's mother passed away while he was in high school, leaving him parentless. A group of local ladies in Ely took him in, and gave him the job as their house handyman. He described Nevada in the 1950s as a mythic place: while in high school his class was taken to watch atomic bomb test explosions, visible to a student's naked eye.

He attended the University of California, Berkeley on an NROTC and track scholarships. During his track career, he nearly cleared seven feet in the high jump. After graduation, he entered the Marine Corps in the 1960s, serving two tours in Vietnam and earning two Purple Hearts and a Bronze Star. He mustered out a Captain in the Marine Corps. SEMPER FI. Following his time in Vietnam, he pursued a Master's degree in English at the University of California, Irvine.

In 1970, he used his VA bill benefits to attend the Collage of Law at the University of Idaho. At the time, he turned down an offer to attend St. Louis University Medical School, his father's alma mater. Upon graduation and passing the Idaho bar, he progressed from private attorney, public defender, prosecutor, magistrate judge until finally senior magistrate judge. Judge Hamlett was originally appointed as a magistrate judge July 1, 1985. He began serving as a senior judge January 1, 2009. All told, he served 36½ years as a magistrate judge in Idaho. He took the job of judge seriously, mentoring all those lawyers who appeared before him. You had to be well-prepared if you wanted to meet his

high standards. Woe be to any who came before him unprepared. He taught criminal procedure at the University of Idaho for many years.

In 1989, Bill married Peggy Wright, a tough, smart and lovely woman and they were together for more than three decades until Bill's death. She was the love of Bill's life. According to his autobiographical obituary, Bill made Peggy smarter, and Peggy made Bill sexier.

At the time of his death, Bill was survived by his wife, Peggy, his loyal dog, Lupita, many loving cats, his Aunt Ruth Pozza and his wife's niece, Emily Baker.

After fighting stage four non-Hodgkin's lymphoma, mantle cell lymphoma, lung cancer, small cell Hodgkin's lymphoma, throat cancer and COPD for twenty years, Bill finally succumbed; however, he worked up until the week before he passed.

Bill was a charitable man who had a kind heart. He enjoyed mentoring attorneys and helping local troublemakers who had good hearts who trouble just seemed to find. He attempted to mete out justice with a sense of proportionality and common sense. He had a strong mind which retained its vigor to the last. He lived a useful and honest life. He will be missed by all who knew him.

## THE HONORABLE GREGORY SCOTT ANDERSON 1945 - 2022

Gregory Scott Anderson was born on September 21, 1945, in Twin Falls, Idaho, to Ralph Stanley and Winnie Elaine Maheras Anderson. He gently passed from this life on his 77th birthday September 21, 2022, in Idaho Falls, Idaho, due to complications of late-stage Parkinson's Disease.

He spent his childhood and youth in Rexburg, Idaho. As a youth, he enjoyed sports like diving, swimming, golfing, skiing, and fishing. He didn't particularly like hunting because his dad didn't have a dog, and when he went hunting with his dad that just meant that he was the bird dog.

He spent a lot of time working with his parents at the Anderson Photo Company on Main Street in Rexburg. He loved to spend time at the family cabin in Island Park.

He was an excellent student and was Valedictorian of his class at Madison High School. He earned many different scholarships for college. He graduated from Ricks College and then continued on to the University of Idaho where he graduated number one in his engineering class with a BS in Chemical Engineering. He received a Masters in Chemical Engineering from Brigham Young University and a Juris Doctor from the University of Michigan.

He was an active member of The Church of Jesus Christ of Latter-day Saints. He served a mission to the Northwestern States, Pacific Northwest Mission. He served in many callings during his life, but his favorite was as Bishop of a student ward at BYU-I. He believed in the Savior, Jesus Christ.

He met Marilyn at BYU, and their first date was the result of him winning a bet with her. They were married on January 22, 1972, in the Cardston Alberta Canada Temple. It was 20 degrees below 0 when they got to Canada for the wedding, and that was as warm as it got the whole time they were there.

Between graduating with his Master's Degree in Chemical Engineering and going to law school, Greg worked for Dow Chemical. It was at that time his daughter, Kelly, was born. Cecily, his second daughter, was born while he was attending law school. After graduating from law school, the family moved to Idaho Falls where Greg started practicing law. It was there that his son, Scott, and third daughter, Meridith, were born.

Greg loved his family above all and he was a great father and husband. He loved to take them hiking, skiing, and boating. He enjoyed attending their sports events. He especially enjoyed hiking, camping, and fishing with his son, Scott. His only problem with his children was when he tried to help them with their math homework. He couldn't understand why they didn't get it because it was so easy. He was so proud of his children and grandchildren.

After practicing law in Idaho Falls for 18 years, he was appointed District Court Judge in the Seventh Judicial District. He served in that position for 16 years, and then as a Senior District Judge for a few years after that.

He was a man of great intelligence and integrity. He always tried to do what he believed was right. He believed in the law. He was very meticulous in everything he did.

Gregory Scott Anderson, 77, passed away on September 21, 2022.



THE HONORABLE EUGENE A. MARANO 1944 - 2022

Gene was born in Tacoma, Washington on August 12, 1944.

From an early age he learned the value of hard work, often picking berries to contribute to the family income. His teenage years were spent working at a local hardware and lumber business which helped him complete his education at St. Patrick's School, then under the Jesuit supervision at Bellermine High School where he made lifelong friendships with the "Bellermine Boys". Gene was a decent athlete, notable student and skilled debater.

After earning his bachelor's degree in history at Gonzaga University, Gene volunteered to join the Armed Forces where he earned his commission as a 2nd Lieutenant in the United States Air Force. After completing Officer's Training and Intelligence Schools, Lieutenant (and later) Captain Marano served in a variety of intelligence positions, most notably in Takhli, Thailand where he was engaged in the operations of the Vietnam War. Upon returning from overseas, he was stationed at Wright Patterson AFB in Dayton, Ohio, After receiving an honorable discharge in 1972, he continued to serve in the Air Force Reserves at Fairchild AFB.

Gene completed his juris doctorate degree at Gonzaga in 1976 and began his legal career in Coeur d'Alene as a Kootenai County deputy prosecuting attorney. Gene also served as a public defender before entering into private practice. In 1985, he was appointed to be a First District Magistrate Judge where he served for 24 years. He was honored to be appointed by the Supreme Court to serve as a Senior Judge until his full retirement.

Gene found great professional pride in his role as a Drug Court Judge. As mentioned in a press tribute, "Marano was a judicial pioneer. He and colleague Judge James Judd in 1998 created the Kootenai County Drug Court, the first of its kind in Idaho."

Gene continued to serve his community after retiring by serving on the Fernan Lake Village City Council beginning in 2018.

Much like his baseball idol, Yogi Berra, Gene was a master of one-line wit, and like Berra, wore #8 while playing youth baseball in Tacoma and later, adult softball teams in North Idaho. Gene was an avid fisherman, woodworker, sports aficionado, wine connoisseur and gardener. More than anything, Gene love spending time with his family. His legacy of treatment court, judicial/educational partnerships and quick wit will be remembered for a long time to come.

VAN G. BISHOP 1946 – 2021

Van was born on August 22,1946 in Nampa. He was raised in Nampa until 1952, when his family moved to Jerome, where his father started a tractor sales company giving Van the opportunity to "drag main" on a tractor.

Van went to college at Utah State University for a short time, and afterward returned to Nampa to work at the local radio stations KCID & KYET. He was then drafted into the United States Army in 1967. After returning home, he joined the police department in Oakland, California, where he worked on routine patrol and in a special operations section on a felony squad during the Black Panther movements.

Van went on to help set up the 911 emergency system for the State of California in 1974 while attending the Lincoln University School of Law. He graduated in 1975 and he and a law school friend opened a practice together in Fremont, California.

In 1981, he moved back to Idaho to raise his family. Van became the Canyon County Public Defender in 1982, where he served the community for 14 years. He then continued in private practice until 2010. His office was a training ground for many attorneys and he was proud to say he had given a start to many of the attorneys and judges in the area. The day someone called him "an institution" at the courthouse made him proud.



Robert "Bob" Kinney was born on September 13,1946 in Yakima, Washington, where he spent his first 18 years.





R. ROMER BROWN 1943 - 2022

R. Romer Brown was born on September 14,1942 in Kellogg. He spent the bulk of his life in Northern Idaho and recalled struggling to breathe while playing baseball as a kid in Kellogg - his throat burning as he stood in left field near the silver mine smelter. That didn't keep him from working as a mine guide for tourists in the summer.

Romer graduated high school as the only Catholic kid, from St Martin's, in Lacey, Washington. Continuing his studies at Oregon State University, as an Alpha Tau Omega member and ROTC cadet, Romer earned a Bachelor of Science/Social Science Degree in 1965. Following in his father's career path, he attended law school, earning a *Juris Doctorate* Degree at University of Denver in 1968. Continuing with ROTC through law school, Romer gained the rank of First Lieutenant by graduation.

After Romer was admitted to the Idaho State Bar in September of '68, he enlisted in the United States Army as the American War in Vietnam was ramping up. In hindsight, this was brilliant as his birth date was drawn 001 of the 1969 Selective Services Draft. Romer's first assignment with an armor maintenance battalion, was to run a tank repair shop. He admitted to having zero familiarity maintaining anything but quickly figured out it was just managing part orders and doing paperwork. He then completed a tour of duty in Vietnam as a general's aide in Ho Chi Minh City, often accompanying the general to see much of the tropical country by helicopter or driving a jeep. His most memorable experience of the American War in Vietnam was being in an outdoor shower stall while incoming mortar shells went off nearby and having to hug the ground, naked, as explosions eroded his hearing. Prior to being honorably discharged, he gained a rank of Captain and earned a Bronze Star.

Before returning to Idaho, Romer traveled around Europe on his own, igniting a travel bug that he would itch often in his life. Though he traveled as far away as the Cook Islands and Fiji, Romer more often opted closer to home, and most often in the woods, with life-long friends while camping, fishing and hiking.

When he finally made it back to Idaho after the war, Romer served as Assistant District Attorney in Coeur d'Alene for six years, before starting his own law firm, in 1978. The office building and practice was a fixture in downtown Coeur d'Alene until 2015. By 2018, he had been admitted to the practice of law for 50 years.

As a member of Ducks Unlimited, a Kiwanis Club Kiwanian for 25 years, North Idaho College Foundation Board Director, a founder of Family Promise of North Idaho which provides support to end family homelessness, it was clear to many that Romer spent a great deal of time and resources to better his local community through philanthropic endeavors, not only as a part of these organizations, but individually. There's a good chance you or someone you know in the community was impacted by Romer's time and efforts.

PHILIP CRAIG STORTI 1946 - 2022

Philip Craig Storti was born in San Francisco on April 13, 1946. Upon the death of this father, Craig and his mom relocated to Buhl to be near extended family and where she served as a school teacher.

Craig excelled academically, athletically and socially through the Buhl public school system. He graduated as Valedictorian from Buhl High School and, among various other clubs and activities, starred as quarterback for the football team, point guard for the basketball team and led the Indians golf team.

Craig attended the University of Idaho, earning a degree in economics. Craig was a proud member of the Phi Gamma Delta fraternity through which he developed many valuable and lifelong friendships within the Fiji House and beyond.

Craig enrolled in law school at Hastings College of Law in San Francisco, earning his law degree at the top of his class in 1971. Upon graduation, Craig served as a law clerk to Idaho Supreme Court Justice Robert Bakes.

In 1975, Craig and his family returned to Boise, where he was employed with Idaho's oldest and largest law firm, Hawley Troxell Ennis & Hawley. Craig loyally and proudly served the firm for nearly 40 years, first as an associate attorney, then partner and then Managing Partner. He developed a stellar reputation as a tough, but fair, trial attorney, ultimately specializing in construction claims litigation. He was invited to be a Fellow in the American College of Trial Lawyers and was also a Member in the American College of Construction Lawyers, among various other professional organizations.

His cases involved widespread travel both domestically and abroad, including large cases in Sweden, Germany and Egypt.

In 2004, he left private practice to serve as an in-house lawyer and Vice President of Litigation and Claims for Washington Group International, Inc. (formerly known as Morrison-Knudsen and later known as URS Corporation) until his retirement in 2015. He also put his expertise and experience to work as a private arbitrator and mediator helping parties resolve their disputes and served on the American Arbitration Association's Construction Panel and on various dispute review boards including for the Idaho Transportation Department.

Craig was also an active contributor to the Boise community, including roles on committees and the Board of the Boise Family YMCA. For decades Craig could be found playing basketball during the lunch hour at the Downtown Y and earned a coveted photo on the "Noon Ball" Wall of Fame. His trademark sweeping left-handed hook shot tallied plenty of points, but he more deeply valued the competition and comradery with the other players, who came from all walks of life.

Bob was born in Butte, Montana on March 31,1940. In 1969, Bob was admitted to practice before the United States Supreme Court with Justice Earl Warren. He served as Lawyer Representative for the Ninth Circuit Court of Appeals from 1997-1999; was director of Idaho Law Foundation, 1995-1998; awarded Idaho State Bar Service Award and Professionalism Award for the Fifth District in 2000. In 2009, he received the Idaho State Bar Distinguished Lawyer Award. He also served on the University of Idaho Foundation and was chairman of its Board of Directors.

In 1965, Bob became attorney for the College of Southern Idaho through its inception and growth until his retirement in November of 2018, serving CSI for 53 years. Being attorney for this institution was his greatest pride. Because he spent more time than anyone in the board room, it is now named The Bob Alexander Board Room. Bob served on the Board of Directors of the new St. Luke's Magic Valley from 2006 to 2016. He contributed to the bond election for the new hospital, its construction, and growth. He served as Board Chairman 2013 - 2015.





DAVID A. JOHNSON 1958 - 2022



Julie Hohbach Piper, 55, passed away on December 4, 2022.




DENNIS R. BYINGTON 1949 - 2022

Jon earned a Bachelor of Science Degree in Political Science from Kansas State University where he graduated *cum laude* in 1977. He went on to earn a master's degree in political science (American Government and Public Administration with a Minor in Community and Regional Planning) from the University of Nebraska in 1979. Jon continued his pursuits of higher learning at Washburn University in Topeka, Kansas, where he earned a *juris doctorate* in 1982, graduating in the top third of his class. He would have also wanted noted how long he spent paying back the student loans and was never anyone to leave money on the table. Just ask anyone who ever played penny poker with him.

Jon practiced law in Boise for 35 years. During that time, he touched the lives of many. He offered nonjudgmental guidance when often they were facing some of the worst moments of their life.
