The following list includes the names of court interpreters certified by the Idaho Administrative Office of the Courts. Interpreters on this roster have passed a written screening exam, attended a two-day orientation workshop, and passed an objective oral examination with a 70 percent or higher in the simultaneous interpreting and consecutive interpreting portions and an average of 70 percent across both sight-English and sight-foreign. (This is not a Master level). Additionally, interpreters listed have complied with continuing education and administrative requirements, stipulated by the Administrative Office of the Courts. Certified interpreter credentials are renewed every two years.

The Idaho Administrative Office of the Courts has access to certification exams for the following languages: Arabic, Bosnian Serbian Croatian, Cantonese, French, Hatian-Creole, Hmong, Ilocano, Khmer, Korean, Laotian, Khmer, Mandarin, Marshallese, Polish, Portuguese, Russian, Somali, Spanish, Tagalog, Turkish and Vietnamese.
