Legislative News – Week #6

Last Friday, JFAC unanimously (20-0) adopted its FY2014 General Fund budget number at \$2.783 billion, or what amounts to a 3% increase from last year, which figure also matches the Governor's recommendation. This translates that JFAC cannot set total budgets from general fund monies meeting the total requests received which so far exceed \$2.8 billion dollars.
