[H 29](#), the Court's bill adding three new District Judges, has been forwarded to the Governor for his consideration. The bill passed both the House and Senate unanimously.



Monday, March 4, marked the Idaho Territorial Sesquicentennial Celebration with festivities on the front steps of the Idaho Capitol. The ceremony, which was attended by Justices of the Idaho Supreme Court and Judges of the Court of Appeals, paid homage to President Abraham Lincoln who signed the resolution creating the Idaho Territory 150 years ago.
