### Court Issues Request for Proposal (RFP) for New Case Management Solution

On May 6<sup>th</sup>, the Design and Implementation Team (a subcommittee of the Court Technology Committee) issued a request for proposal (RFP) for a comprehensive, fully integrated statewide court case management solution. The team is seeking proposals from qualified offerors for commercial off the shelf products to replace ISTARs and provide advanced functionality to include e-filing, a judge's interface (workbench), enhanced reporting, and much more. The RFP process will enable the team to fully evaluate all potential options available in the technology marketplace as the courts move forward with modernizing our case management application. Vendors are requested to provide responses by May 28<sup>th</sup>; the Design and Implementation Team will make a final recommendation to the CTC on July 11<sup>th</sup>. ## Bingham County Holds Sesquicentennial Open House

On March 14, 15, and 16, 2013, Bingham County sponsored an Open House at the Courthouse to commemorate "Idaho at 150," a territorial sesquicentennial celebration. Bingham County was established in 1885 during the territorial period.

Display stations highlighting the County's historical records lined the hallways of the courthouse. Each station featured an employee or volunteer who gave a short presentation. Fourth grade students from local elementary schools were issued a special invitation and those attending were treated to several interactive learning activities to supplement their study of Idaho history.

Volunteers dressed as early historical Bingham County residents were in the halls. Each had a question mark pinned to their clothes signifying they would love to talk to visitors and introduce themselves and tell about their lives. Commissioner Mark Bair portrayed Bingham County's first Commission Chairman, Henry O. Harkness.



It is estimated that approximately 1,000 students and residents toured the courthouse during the 3-day event.

A big drawing card was the re-enactment of an 1887 murder trial held in Blackfoot, Territory of Idaho v. Alexander Woods. Mr. Woods was accused of murdering his wife, Sarah Woods, in Pocatello, which at the time was located in Bingham County.

Deputy Court Clerks Pam Eckhardt and Kristie Bell were excited when they found the old file while completing a scanning project. In addition to documents relating to the case, some of the evidence was also found within the file jacket. This evidence consisted of a .41 caliber bullet, a portion of the victim's skull, and a telegram.

When the file was brought to the attention of County Clerk Sara Staub, she felt that a re-enactment of the trial would be a great addition to the sesquicentennial event. She condensed the transcript of the 3-day trial into a one-hour screenplay and recruited briefing attorney Lauren Murdoch to direct the play.

## Bingham County Holds Sesquicentennial Open House . . .

Feeling that the only thing missing from the play was some music, Lauren's husband, Dr. Matt Murdoch, composed and performed an original ballad, the "Ballad of Sarah Woods." The chorus to the song summed up the motivation behind the crime, "Must have been a mighty rage, that left her lifeless in the sage," as the defendant admitted to a reporter, "that he was so wild with rage that he knew not what he was doing."

Jurors were selected from the audience at each performance and, although males and females filled the jury box, each was given a mustache to wear to illustrate that in 1887 only males were allowed to serve as jurors.



Mr. Woods was hung at the courthouse on August 17, 1888, after two daring escapes and a one-month stay of execution issued by the governor. The presiding judge in the case was Judge Case Broderick, who, coincidentally, heard the case on appeal confirming the district court verdict.

The re-enactment was held in the County's large courtroom with five performances scheduled. Actors in the play included Magistrate Scott Hansen, attorneys Randy Smith, Mark Cornelison, Jim Archibald, Trevor Castleton, and Manuel Murdoch. Other actors included two former County Commissioners, Wayne Brower and Donavan Harrington, court reporter

Dan Williams, two employees from Indigent Services, Sharon Sturm and Susan Denny, the President of the Bingham County Historical Society, Marty Ellis, and five volunteer citizens, Larry Christian, Dan Neff, Jim Wilcox, Gary Eckhardt, and Matt Murdoch.
