At the July 2013 National Association of Drug Court Professionals (NADCP) Conference, Dr. Doug Marlowe presented the Adult Drug Court Best Practice Standards Vol. I (They have reported that a second volume will be available in the Fall).

The Drug Court and Mental Health Court Coordinating Committee will hear a short summary of these standards at the October 7, 2013 meeting. We anticipate re-convening the adult drug courts standards and guidelines sub-committee for potential revisions of the attached Idaho Adult Drug Court Standards & Guidelines for Effectiveness and Evaluations, sometime in the next few months.
