Entry fee: \$60.00 per person (includes: green fees, cart & non-alcoholic beverages)
Make Check Payable to Elmore County Friends for Recovery Council, Inc., (ECFRC).

Format: 2 person best ball holes 1-6, Chapman holes 7-12, and 2 person scramble holes 13-18
If you do not enter a 2 person team, you will be placed with a partner

Procedure: **Best ball:** Each player plays his/her ball throughout the round, and on each hole the low score of the group serves as the team score.

Chapman: both players tee off, then switch balls. Player A plays Player B's drive, and vice-versa. Each player hits his or her second shot. They then select the best of the second shots, and from that point until the ball is holed they play only one ball in an alternate shot format.

Scramble: each player tees off on each hole. The best of the tee shots is selected and all players play their second shots from that spot. The best of the second shots is determined, then all play their third shots from that spot, and so on until the ball is holed.

Handicap: 60% Player A handicap+ 40% Player B handicap divided by 2
You do not have to have a handicap to enter.

Cancellation Policy:

1. If golf tournament is canceled due to weather or other events, player will receive a full refund
2. If player cancels, 48-hour notice is required to receive 50% of entry fee
3. If player is a "no-show", entry fee is non-refundable.
