#### Legislative News: Week 12 and Sine Die

After the Legislative News went to print last Friday, March 24, 2017, the House passed SB 1201 on a vote of 63-3-4. SB 1201 is the trailer bill to appropriate the monies necessity. sary to pay the Judges' salary increases in the total amount of \$707,800 a year and will require on-going appropriations from the general fund. SB 1108 is this year's judicial pay bill which would amend I.C. §59-502. The Governor signed SB 1108 into law on March 27 and the Court's appropriations bill SB 1160 into law on March 28. As of this writing, there has been no action by the Governor on SB 1201 has been no action by the Governor on SB 1201.

The Court's four defects in the law bills this session were all signed into law by the Governor on March 27. These are:

- SB 1023 amending I.C §49-2706 (relating to funeral processions);
- SB 1024 correcting errors in the definition of a "protective order" in I.C. §16-1602(34);
- SB 1025 amending I.C. §1-907 (relating to administrative judges);
- SB 1026 amending I.C. §19-2604 (relating to the amendment of criminal judgments).

SENIOR JUDGE MANUAL "DRAFT" AVAILABLE

Currently, there are three separate Senior Judge Manuals (Senior Judge Manual, Plan B Rules, and Purchase of PERSI Service Manual). The manuals were created as each plan was approved by the Legislature. The Human Resources Division has been working on combining these manuals relating to senior judge service into one manual for ease of use by senior judges, judges considering applying for senior judge status, and those working with senior judges. In addition to combining the three policy manuals, we have updated policies and procedures to provide greater clarity where policy and procedure has been vague or nonexistent and to address concerns that have come up over the years. ## iCourt Project Update

#### Wave 1 Activities



Clerks from Canyon and Owyhee counties will participate in a data review workshop next week in Canyon County. The workshop will provide the clerks with a first look at the data converted from ISTARS into Odyssey to help identify any issues with the conversion. The Tyler Tech implementation team has converted the first push of data from ISTARS into a refreshed Odyssey environment for all 12 counties in Wave 1 to review.

#### Wave 2 Activities

Resources from the iCourt Project team, ISC and Tyler Technologies will travel to the counties in Districts 1 and 2 (Benewah, Bonner, Boundary, Clearwater, Idaho, Kootenai, Latah, Lewis, Nez Perce, and Shoshone) in late April to provide an on-site demonstration of the Idaho Odyssey product. The Odyssey demonstration will introduce judges and staff in those counties to the new Idaho iCourt technology, as well as provide a forum to address questions and answers related to the project.

Focused work continues on improving forms and document security. Policy decisions will be sent to committees for review prior to process implementation.

#### Updates from your Language Access Office

We have had very exciting and busy couple of weeks! Interpreter oral certification exams were administered on March 9 & 10. We are very happy to report that Gabriella Lago became an Idaho Certified Interpreter for the Spanish language. Gabriella's contact information will soon be added to the Certified Interpreter Roster online.

On March 24<sup>th</sup> we participated in a mock immigration merits hearing part of a collaboration project between law students at Concordia Law University and interpreter students from Boise State University. Law professors and immigration attorneys who organized the mock hearing were, Nicole Derden, Angela Richards, and Angela Levesque. Professor, Fatima Cornwall, from the Department of World Languages at Boise State University provided the linguistic services for the project. On Saturday, March 25<sup>th</sup>, the Idaho Supreme Court hosted the first Ethics Review & Written Exam Preparation Course. This training is part of the redesigned Court Interpreter Training & Certification Program. The all-day program was facilitated by Boise State University Professor, Fatima Cornwall. Twenty certification-candidates worked diligently to improve their skills and understanding of the profession. Additionally, everyone was delighted and encouraged by welcoming comments offered by Justice Brody. Earlier in her career, Justice Brody worked closely with translators and interpreters. As such, she understands the pressures interpreters face when working in court. During her remarks, Justice Brody reminded participants how important ethical behavior is- even under the most pressing of circumstances.

On March 27<sup>th</sup>, Canyon County hired Grace Arroyo as their new staff interpreter. Grace became certified as a Spanish interpreter in 2003 and has many years of experience working for the Idaho courts. Everyone in Canyon County is excited to have her- congratulations Grace!
