

The Elmore County Drug and DUI Court became operational on October 5, 2010. This is a specialty court based on a system of immediate sanctions and incentives. We target felony drug offenders and "hardcore" DUI offenders - those who have a pending second or excessive DUI or multiple lifetime DUIs. The program is an intensive supervision, accountability and treatment program, which lasts on average 14-18 months depending on the progress of each participant. We not only deal with substance abuse issues, but address all aspects of our participants' lives, including parenting, employment, education, and community service.

Through fundraising efforts, we hope to increase our ability to provide appropriate treatment and counseling services to participants in the Elmore County Drug and DUI Court, emergency safe and sober housing, medical visits, educational services, drug testing and incentives, along with ongoing staff training. We also want the community to join in our effort to stop reoccurring drug and alcohol abuse and the crimes that come along with addiction.

## 2nd Annual ALL RISE OPEN Golf Tournament

**Date:** AUGUST 11<sup>th</sup>, 2012  
**Time:** Registration at 7:30 AM. Shotgun start at 9:00 AM

**Entry fee:** \$60.00 per person (includes: green fees, cart & non-alcoholic beverages)

**Format:** 2 person best ball holes 1-6, Chapman holes 7-12, and 2 person scramble holes 13-18

If you do not enter a 2 person team, you will be placed with a partner

**Procedure:** **Best ball:** Each player plays his/her ball throughout the round, and on each hole the low score of the group serves as the team score.

**Chapman:** both players tee off, then switch balls. Player A plays Player B's drive, and vice-versa. Each player hits his or her second shot. They then select the best of the second shots, and from that point until the ball is holed they play only one ball in an alternate shot format.

**Scramble:** each player tees off on each hole. The best of the tee shots is selected and all players play their second shots from that spot. The best of the second shots is determined, then all play their third shots from that spot, and so on until the ball is holed.

**Handicap:** 60% Player A handicap+ 40% Player B handicap divided by 2  
You do not have to have a handicap to enter.
