Additionally, interpreters listed have complied with continuing education and administrative requirements, stipulated by the Administrative Office of the Courts. Master Level Certified interpreter credentials are renewed every two years.

The Idaho Administrative Office of the Courts has access to certification exams for the following languages: Arabic, Bosnian Serbian Croatian, Cantonese, French, Hatian-Creole, Hmong, Ilocano, Khmer, Korean, Laotian, Khmer, Mandarin, Marshallese, Polish, Portuguese, Russian, Somali, Spanish, Tagalog, Turkish and Vietnamese.
