If the parents can work out an agreement, the Mediator helps them write the parenting plan, which may become a custody and visitation order when signed by a judge.

These mediators are governed by [Idaho Rules of Family Law Procedures Rule 602](#) [1] and [Idaho Rules of Evidence Rule 507](#) [2].
