Domestic Violence Evaluators provide the court with valuable information when working with persons convicted of domestic assault, domestic battery, or attempted strangulation. The evaluation submitted to the court includes a risk assessment, identifies possible substance abuse or mental health issues, and provides recommendations to the judge in several key areas.
