DHW Funded Slots	Number of DHW funded slots currently allotted to the specific court
DHW Participants	Number of active participants associated with DHW Funded Slots as of the last day of the month
DHW Slots Remaining	DHW Funded Slots minus DHW Participants as of last day of the month
DHW % Utilization	Number of DHW Participants divided by DHW Funded Slots
